

## **Data processing in connection with the use of cookies**

Our website uses cookies to ensure its proper functioning and to provide essential and convenience functions, for marketing purposes and to compile anonymous statistics.

A cookie is a file (packet of information) that is placed on the browsing device when a data subject visits a website. The use of cookies allows the visitor to be asked for certain data and to record his/her Internet usage habits. In general, cookies can facilitate the use of a website, help the website to provide the data subject with relevant information and allow the website operators to monitor the functioning of the website (e.g. to prevent abuse and to ensure that the services available on the website are adequate).

Cookies from third parties may also appear on our website. In the case of third party cookies, the third parties identified in the table in this document are the data controllers, and our Company as Data Controller has limited control over third party cookies, and such third party processing is governed by the third party's privacy policy. These cookies provide functionality without which the Website cannot function properly, the use of these cookies is strictly necessary, and the legal basis for the processing of the data in this context is the legitimate interest of the Data Controller to ensure the proper functioning of the Website.

## 2. Functionality and performance, statistical cookies:

These cookies collect information about visitors to the Website anonymously, using a customer identification code randomly generated by the cookie, for statistical purposes. These cookies allow us to monitor and improve the performance of our site, for example, they allow us to track the number of visits, identify the source of traffic and the most popular parts of the site. The data does not enable the Data Controller to identify the Data Subject and does not take steps to

identify the Data Subject. The purpose of the processing is to provide the Data Controller with information about the website traffic and other statistical data to enable the Data Controller to improve the website and increase its security. The legal basis for the processing is the consent of the Data Subject, which can be given in the cookie pop-up window on the first visit to the website. If the user does not change the pre-set ticks, the Functionality and Performance cookies will not be installed automatically. The Data Controller will use the data anonymously for statistical purposes, analysis and no automated decision-making will be made on this basis, nor will the Data Controller send personalised offers to users on this basis

### 3. Marketing cookies:

The purpose of using marketing cookies is to select the ads that are of most interest or interest to our visitors and display them on our website. The legal basis for the processing is the consent of the Data Subject, which you can give in the cookie pop-up window on your first visits to the website. In the pop-up cookie window, only the checkbox for the cookies that are strictly necessary is ticked (the legal basis for their use is not the user's consent), and consent to the use of marketing cookies is given by ticking the Marketing cookies checkbox. If the user does not change the pre-set checkboxes, the Marketing cookies will not be installed automatically.
